

# Municipal Elections

The next General Election will be on Saturday, May 7, 2022. Filing for a place on the ballot is set by state statute and will run from Wednesday, January 19, 2022 to Friday, February 18, 2022 at 5:00 p.m. Positions for election in 2022 are City Mayor, City Council Member Position 2, and City Council Member Position 4.

## May 7, 2022 General Election

Texas Election Code Section 141.040 requires the City to post a Notice of Deadline to File an Application for Place on the Ballot

## **Candidate Information**

To be eligible to be a candidate for, or elected or appointed to, a public elective office, a person must:

1. At least 18 years of age.
2. A Citizen of the United States of America.
3. A registered voter in the State of Texas.
4. Shall not have been convicted of a felony criminal offense or a crime involving moral turpitude.
5. Shall not be in violation of any other provision in the City Charter.
- 6a. Additional requirement for Mayoral candidate:  
Shall be a resident of the City and shall have resided within the corporate limits of the City for at least one year.
- 6b. Additional requirement for Council candidate:  
Shall be a resident of the City and shall have resided within the corporate limits of the City for at least six months.
