<u>PLAN PRESENTATION</u>. Plans along with a Permit Application are to be submitted to the Commission for approval. The Commission shall review the proposed package and give its written approval/disapproval within thirty (30) days after the date of submission.

ROOF PERMIT.

According to the City Ordinance 2022-452 and the 2018 International Building and Residential Codes the following will be required by the roofing company or home owner. Inspection must be done upon completion.

- a. Wood shingles may not be used for roofing or siding on either new construction or for the replacement of existing roofs.
- b. All roof replacement must be either composition fire retardant materials or approved metal roof material, and all vent pipes must be reinstalled.
- c. A carbon monoxide alarm shall be installed and inspected as part of a roof replacement in homes with gas fired appliances.

<u>ROOF PERMIT FEE:</u> A permit fee for the installation and final inspection of a roof permit will be One Hundred and Fifty Dollars (\$150.00).

ROOF INSPECTION: A final inspection is required to verify the installation of the roof. The first inspection shall be covered by the Building Permit. If City Inspections fail there will be a reinspection fee that will need to be paid prior to reinspection.
